## **ALERT:** Licensing authority policy change



On 26 June 2017 the licensing authority amended its important and well known policy regarding responsible promotion of liquor to include references to social media. The policy provides that it is **unacceptable** for licensees to do the following:

Offer, provide or distribute promotional cards, vouchers or incentives away from the licensed premises or conduct any other form of advertising, **including by social media**, that provides free or discounted drinks.

# Liquor Commission decision confirms need for supporting evidence

In a recent decision of the Liquor Commission, in relation to an application to vary the conditions of a licence, it was determined that the applicant's case was not supported by sufficient or probative evidence and as a result the Commission refused to find in favour of the applicant.

It is not enough for an applicant to make submissions and claim certain things about their business or their customers without proof.

The case, which related to Squires Fortune in Scarborough, also confirmed the long established principle that private and commercial interests of parties in relation to liquor licensing are irrelevant. The public interest is paramount.

### Summary of decisions of the Director of Liquor Licensing published in June 2017

Name of premises	Outcome	Notable points
Liquorland Trinity	Successful	There were no objections or interventions, but the Director noted that fact did not lead to any automatic approval or "presumption in favour of the grant".
BWS Banksia Grove	Successful	An existing level of alcohol-related harm was found to exist, above State averages, but it was found that the new licence would be "unlikely to increase that rate of harm above what might be commonly accepted in the community".
Lemas	Successful	There were two interventions and two objections – one by a party claiming to be the lawful occupant of the proposed tavern premises. Several paragraphs of the decision deal with the issue of juveniles, as raised by the Health Department, particularly in regard to the proposed rooftop cinema. The Director determined in favour of the applicant and noted – as is relevant to all licensees – that "an older sibling or friend accompanying a juvenile…would not be considered to be compliant with the requirements of the Act".
Monk Craft Brewery Kitchen	Successful	Several special conditions were imposed on the approval, including that only liquor produced by the licensee may be sold for take-away, "substantial food" must be availbale at all times, the licensee is prohibited from moving tables and chairs except in certain circumstances and liquor cannot be sold in jugs.
Yonder Bar	Successful	There were no objections or interventions. Trading hours were approved from 5pm and the maximum number of patrons permitted at any time is only 25.
Marketta	Successful	The large premises was approved for 900 patrons. There was some issue in the determination as to noise and criticism from the Director that the applicant rejected conditions proposed by Police which were conditions consistent with the applicant's PIA.
Piggy Food Co	Successful	Two local residents objected. The Director determined that the objectors did not make out their case and the evidence did not establish that noise from the venue would have such an impact as to be adverse to the amenity. A condition was imposed requiring tables and seating for dining.
Oyster Bar Elizabeth Quay	Successful	The Director reiterated the important principle that "the onus falls upon the applicant to satisfy the licensing authority that the grant of the application is in the public interest" and went on to find as follows:  "I have considered the applicants' evidence and submissions, particularly in view of the nature and scale of the Elizabeth Quay project and the benefits to the State to be realised from this development. I am of the view that the grant of the application would be consistent with objects 5(1)(c) and 5(2)(a) of the Act. I find that the positive benefits of the application outweigh any potential risks, which can be mitigated through the imposition of appropriate conditions as recommended by the CHO or by standard conditions normally imposed by this
